The Hong Kong Symposium in Travel Medicine 2019 aims to raise awareness among healthcare professionals and the public on the importance of travel health advice, risk assessments and chemoprophylaxis such as travel vaccinations.

This year's symposium is a joint event organised by the Hong Kong Society for Travel Medicine Founding Group (HKSTMFG), the Society of Hospital Pharmacists of Hong Kong (SHPHK) and the University of the Hong Kong Department of Pharmacology and Pharmacy. It is the first travel health practice forum to be held in Hong Kong and is the practice forum for communicating and learning about current trends, reviewing the lessons learned, best practices, effective practice principles, relevant issues, different points of view and the implementation challenges commonly associated with travel health practice.

Through global and national partnerships, and the sharing of clinical experience and standards, it is our goal to advance the development of Travel Medicine and Global Health in Hong Kong by providing comprehensive and evidence-based travel health services with appropriate practice guidance.

It is the organising committee's hope that through active sharing of best practices among specialist travel health practitioners, we will create the gold standard for clinical practice within travel vaccination and immunisation clinics in Hong Kong and the Far East.

## Introduction from Honorary chair.

Director of Infection Prevention and Controlat the Royal Centre for Defence Medicine, immediate Past Dean of the Royal College of Physicians and Surgeons of Glasgow (RCPSG) The World Tourist Organisation estimates i nternational tourist arrivals worldwide will increase by 3.3% a year to reach 1.8 billion by 2030. International tourist arrivals in the emerging economy destinations such as Hong Kong will grow at double the pace (+4.4% a year) of that in advanced economy destinations.

Most travellers still go to countries in developed areas of the world; however there is a rapidly i ncreasing number of people travelling to remote and less developed countries. With continued growth in travel to diverse locations, there will undoubtedly be an increase in the need for adequate pre-travel advice for travellers.

Overseas travel is associated with a significant burden of disease and injury, and a corresponding economic impact as indicated by travel insurance claims, reported deaths of nationals in overseas locations, and various studies examining specific disease patterns (such as malaria and gastrointestinal disease). However the commonest causes of illness are trauma (especially road accidents) in younger groups, and cardiovascular disease in older populations. Vaccine preventable diseases cause a relatively small number of infections, despite commercial marketing which suggests a much greater burden.

Travellers are also recognised as the means by which many new and emerging infectious diseases move around the globe. The introduction of novel pathogens may have profound consequences for both the health systems of receiving countries and longer term economic effects. Examples from the last 20 years include HIV/AIDS and the spread of multi-drug resistant bacteria. In the last decade there have been significant public health problems caused by travellers with SARS, and more recently H1N1 influenza and MERS-CoV.

A relatively new phenomenon is that of medical tourism, with patients travelling to different countries to receive medical care (including surgery) before returning to their homeland. There is increasing evidence that this is associated with spread of difficult-to-treat multi-drug resistant bacteria acquired in the host health care environment, and subsequently spread when the patient returns to their home.

It is against this backdrop that a new organisation in Hong Kong is being launched. The aim is to deliver a means of assuring that travellers to and from Hong Kong receive the highest quality advice and medical care. Setting high standards that are benchmarked against those of internationally recognised organisations is an important first step, which in turn allows the highest quality of training and education.

The presentations given during the Public Awareness Day are intended to describe the spectrum of activity that is covered by the field of Travel Medicine, and to demonstrate the level of expertise that currently exists in Hong Kong.

### Dean's Lecture Speaker Group Captain Andy Green

Immediate past Dean of the Faculty of Travel Medicine, Royal College of Physician and Surgeon of Glasgow and Defence Consultant Adviser in Communicable Disease.

Gp Capt Andy Green trained at St George's Hospital Medical School, London and joined the Royal Air Force in 1983 after house jobs. He trained as a specialist in Clinical Microbiology, and was appointed Consultant Microbiologist in 1991.

He is currently Defence Consultant
Adviser in Communicable Diseases,
and advises the Surgeon General on
all aspects of infectious diseases and
their control, including biological
warfare. Gp Capt Green sits on a
number of national and international
committees, both military and civilian.
He has published over 100 scientific
articles, and has research interests in
Travel Medicine and disease
transmission on-board aircraft.

In 2009, he was appointed Director of Infection Prevention and Control (IPC) with a remit to lead the development of IPC practice across the Defence Medical Services, and moved to his current position at the Royal Centre for Defence Medicine in Birmingham.

During the summer of 2014 he became one of the Military leads advising on clinical aspects of the Ebola Virus Disease (EVD) response of the United Kingdom. He continues to act as a specialist adviser to the Department of Health and the World Health Organization on transportation of patients with highly transmissible infectious diseases. He was appointed as Dean of the Faculty of Travel Medicine in October 2015.

# Dr. Tommy Tang Practicing Infectious Disease Physician

Tommy Tang is a practiscing an infectious disease physician in Hong Kong. He has various peer-review publications including the Emerging Infectious Diseases, the Clinical Infectious Diseases, and the New England Journal of Medicine. He also received post-graduate training in travel medicine in UK.

Alex is the Chair of the first Pharmacists Travel Medicine Conference 2018 in the UK with the aim of enhancing the clinical expertise of travel clinic pharmacists. He is a keen advocate for training pharmacists to provide sound, evidence-based Travel Health advice while working to a comprehensive risk assessment process.

Alex believes the sharing of practical experiences of frontline clinicians and Travel Medicine experts will inspire fellow pharmacists to progress to become advanced Travel Health/Travel Medicine clinicians. This is the purpose of the Travel Medicine conference.

Alex is a Fellow of the Royal Society for Public Health and is interested in global health issues within the context of Travel Medicine. Alex is also a Specialist Pharmacist Independent Prescriber and has been serving as a frontline Travel Health clinician for more than seven years. He is the Head of Travel Medicine and Allergy Services at five GP surgeries and pharmacies and the Chief Pharmacist for Shell UK, working with the Shell Occupational Health team in improving clinical services.

Alongside his daily duties, Alex has been working on multiple projects with the goal of raising awareness regarding the importance of Travel Medicine services and its educational need in both the UK and Hong Kong.

Alex is a board member of the Royal College of Physicians and Surgeons of Glasgow (RCPSG) Faculty of Travel Medicine Education Board (FTMEB) and is tasked, along with fellow board members, to work with the Royal Pharmaceutical Society (RPS) to set the competencies framework of pharmacists' travel health clinicians and the clinical standards of pharmacy travel clinics in the UK.

Alex is the president (Overseas Affairs & Global Engagement) and co-founder of the Hong Kong Society of Travel Medicine (HKSTM), which aims to raise the public's awareness of the importance of Travel Health for Hong Kong and China travellers. Alex is an advocate for the empowerment of Hong Kong (HK) pharmacist professionals to become trained vaccinators, providing influenza vaccinations utilising skilled healthcare professionals.

Alex is also the education director of a PGD-accredited training course on travel vaccinations, seasonal influenza and injection techniques. To date, he has educated more than 1,400 UK pharmacists in this field. He is a qualified First Aid & Resuscitation Training Instructor, including First Aid At Work (FAAW) and an AED and Paediatric/Childcare First Aid Instructor, providing paediatric and adult CPR anaphylaxis courses.

I completed my MBBS degree in 2009. After internship, I started my training in internal medicine in the Queen Elizabeth Hospital in 2010. With special interest in infectious diseases, I continued my training in this field following completion of the MRCP examination. After finishing my specialty training, I looked for further study and enrolled the Royal College Membership Diploma in Travel Medicine Course. I completed the Membership of the Faculty of Travel Medicine Examination (MFTM) in December 2018.


Dr. Kai N. Cheong is a Paediatric fellow specialising in Immunology, Infectious Diseases and Allergy at Queen Mary Hospital, and an honorary lecturer in Paediatrics and in Medical Humanities at the University of Hong Kong. She was awarded her Diploma of Tropical Medicine & Hygiene by the Liverpool School of Tropical Medicine (with distinction) in 2015. She is the Bill Marshall Memorial Fund Fellowship awardee of 2017, and recently completed a year of overseas training at Great Ormond Street Hospital (UCL) in London specialising in Immunology, Infectious Diseases, Bone Marrow Transplantation and Rheumatology. In 2015, she became the first paediatric trainee in Hong Kong to be allowed the opportunity to interrupt her training for a humanitarian mission. She is the first paediatrician from Hong Kong that the international NGO Médecins Sans Frontières (MSF) has sent into the field.

Dr Abraham Wai is a specialist emergency physician working in Emergency medicine Unit. He received his medical degree and law degree at the Chinese University of Hong Kong at 2004 and 2010 respectively, and MBA at Hong Kong University of Science and Technology in 2013. Before joining HKU, Abraham worked at Emergency Department at Prince of Wales Hospital, teaching medical students on clinical methods, emergency medicine, medical law and professionalism. He also conducted research on medicolegal issues and complaint management. He also served in Hospital Authority Head Office overseeing technology assessment and management, through the promotion and application of evidence-based medicine practice. During his service at Tseung Kwan O Hospital as associate consultant, he coordinated the clinical simulation training at Kowloon East Cluster of Hospital Authority, and coordinated advanced disaster training for Hong Kong Academy of Medicine. He underwent Comprehensive and Advanced Simulation Training Programs at Harvard University in 2016.

With his broad range of interest in clinical medicine, medicolegal ethics and health service management, Abraham published the first local medical law textbook 'Medical Law & Ethics in Hong Kong' in 2016. Recently Abraham also actively participated in the development of healthcare mediation through his educational leadership in Hong Kong Society for Healthcare Mediation, which aims at the enhancement of both communication skills among healthcare professionals and effectiveness of healthcare dispute resolution.
